

PREFACE TO THE FIRST EDITION

This Index of *The Civil and Military Gazette* is basically designed to help researchers working on the Freedom Movement of India, especially the Muslim aspect of it.

The Civil and Military Gazette was started in 1872 from Simla as a weekly newspaper, and its main object was to cover the activities of the Central Government.

In 1876 The Civil and Military Gazette became a daily and shifted its venue of publication to Lahore. It was the first newspaper in the Punjab which published Reuters telegrams. Till the close of the 19th century apart from it, Akhbar-i-Aam was the only other important daily newspaper which was published from Lahore.

During the first half of the 20th century *The Civil and Military Gazette* made a significant contribution in deputing the political scene of the Punjab in particular and that of India in general.

This Index covers the period from 1919 to 1935 during which the British Government gave India two Constitutions i.e. the Montague-Chelmsford Reforms of 1919 and the Government of India Act 1935. These Constitutional Reforms went a long way to accelerate the political process in the subcontinent especially among the Muslims.

This Index includes selected editorials, articles and letters to the editor. All entries are arranged alphabetically and chronologically under each heading and show a precise reference including date, page and column. If any entry begins on one page and continues on to another, the reference is confined to the page on which it appears first. The date reference in the Index denotes the date of publication of the item concerned in the C&MG has nothing to do with the actual dateline. Each entry is mentioned only once under the main heading and no cross reference has been considered necessary.

Editorials and Letters to the Editor concerning the foregoing Heading/subheading and dealing with the subject under reference in general terms have been lumped together under the categories of GENERAL/General. PREFACE TO THE SECOND EDITION

This Index of *The Civil and Military Gazette* was originally designed to help researchers working on the Muslim contribution to the Freedom Movement of India. During the past few decades the growth of universities in the public and private sector in Pakistan has increased the demand for primary research sources. This index is one such tool designed to help researchers in the field of history. No changes have been made in the Index except for removing a few typographical errors.

The Civil and Military Gazette, started in 1872 from Simla as a weekly newspaper. In 1876 it became a daily and shifted its venue of publication to Lahore. During the first half of the 20th century The Civil and Military Gazette left an indelible mark on the political milieu of the British Punjab.

The time period covered by this *Index* is between 1919 to 1935, the period when British Government gave India two Constitutions i.e. the Montague–Chelmsford reforms of 1919 and the Government of India Act 1935. This was a time for major political change in the Indian subcontinent.

In the end, I must thank the Director Dr Sajid Mahmood Awan and the Publication Officer Mr Mohammad Saleem of the National Institute of Historical and Cultural Research, Centre of Excellence, Quaid-i-Azam University, Islamabad for reprinting this important primary source of historical research. The book is divided into three parts. The first part lists Articles; second part lists Editorials and the third part lists Letters to the Editor.
